Scribe Policy

- Exam scribe policy provides instructions for physical act of writing or recording answers on behalf of students who are unable to write exam due to their disability, this must be approved by controller of examination well in advance
- If the student is blind/low vision and his/her writing speed is affected such students needs a
 writer as permissible under the government of India rules governing the recruitment of
 physically challenged persons
- 3. Scribe facilities are provided only those candidates who have disability 40% or more and who have physical limitation to write / writing speed
- 4. The scribe provided to write should be from different academic stream of the examination subject.
- 5. The scribe writes or records what is verbalized by the provider or student .the name of the scribe must identified in records . the scribe must sign and date the documentation . the identity of scribe or eligibility should be approved by controller of examination
- 6. The extension of time will be decided based on the disability condition of candidate but extension of time should not be more than 15% of time given for examination.
